We are the ones who live in those "regions outside the Delaware River Basin" where you found evidence of adverse impacts spanning more than a decade.

We are the ones whose air and water quality have been profoundly impacted as a result.

We are the ones who bristled when your statement regarding your vote to ban fracking in the Delaware River Basin referred to its "unique characteristics" because we know that every place has unique characteristics that are worth protecting from industrial polluters.

We are the ones who know that unique doesn't mean more important and that the water that comes out of our taps is no less worthy of protection than the water that flows from taps in the basin.

We are the ones who have asked you repeatedly to meet with us, to visit our communities, to witness the impacts firsthand.

We are the ones you have never had time for.

We are the ones the Grand Jury talked about in its report.

We are the ones who have had to advocate for ourselves because our government has failed to advocate for us.

I was offered contracts by two companies for fracking beneath my home. I signed neither. I do not know how many of my neighbors signed fracking contracts. On the 24.44 square miles that are my township, 38 wells have been permitted on 6 well sites. I have been able to find the location of those wells online.

In 2018 after the Revolution Pipeline explosion and fire in Center Township of Beaver County, I looked online for a map showing the exact location of that pipeline and others nearby. It did not turn out to be the simple search I expected. Finally I found a map of the proposed pipeline in my township that was in an addendum to a state government document. More information is available online now, but it is still not enough. A pipeline laid near the northwest corner of my township feeds into the Revolution Pipeline. Never have I been given any information by local or state governments about the existence of that pipeline. Neither have I been instructed by anyone what to do if there is an explosion of the pipeline near me.

Infrastructure maps are significant sources of information that should be more readily available to citizens. I drew topography maps for an engineering firm with a flood control contract from the U.S. Army Corps of Engineers. Because I sat at a drafting table doing that for 40 hours some weeks, I now visualize spatial information differently than most people. I feel acutely the lack of access to maps.

I have taught two courses about the history of physics and chemistry knowledge related to climate change. The first was in 2018 for the Institute for Learning in Retirement at Slippery Rock University of Pennsylvania. The second was in 2019 for the Chautauqua Institution on its grounds in New York. A similar course I proposed was accepted for 2020 but then was cancelled, along with all the other on-site courses, due to the COVID-19 pandemic.

There is no doubt that continuing to extract, transport, and burn fossil fuels will have disastrous effects.

Anyone who denies this fact is guilty of harm that already has occurred and more that will happen. Government officials at all levels need to immediately stop enabling fossil fuel production/transportation/use through improper eminent domain actions, severe restrictions of and punishments for protesting, lax regulations, corrupted enforcement, unjustified tax breaks, unreasonable subsidies, and all other means.

Constructive change is possible as shown by the reversal of depletion of the ozone layer and the reduction of formation of acid rain. Substantial support must be given for energy production that does not emit particulate matter, greenhouse gases, and other polluting substances. Payments for externalities should not continue to be imposed on people who contract diseases caused by pollution, experience heat exhaustion from excessively high temperatures outdoors, no longer use water from their wells, suffer from noise pollution around their homes, see their neighborhoods destroyed by sea level rise, lose their homes in floods, have crops wither from drought, and endure numerous other effects of burning fossil fuels. The number of people who die from these effects should never be overlooked. When making decisions, much more consideration needs be given to extinction of plants and animals, loss of glaciers, acidification of oceans, collapse of weather patterns, and other deleterious consequences of climate change.

Societal changes based on scientific knowledge should have been made decades ago. The costs of continuing inaction will become unbearable for individuals, businesses, nonprofit organizations, and governments. Environmental catastrophe will result from beneficial changes not being made quickly enough. Please choose to preserve what we have not already lost., Butler
